## THE COUNTY OF CUMBRIA (VARIOUS ROADS, GRASMERE) (CONSOLIDATION OF TRAFFIC REGULATIONS) ORDER 20

- 1. The Cumbria County Council hereby give notice that it proposes to make the above Order under Sections 1, 2, 19, 32, 35, 35A, 38, 45, 46, 47, 49, 51, 53 and 64 of the Road Traffic Regulation Act 1984.
- 2. The effect of the proposed Order will be to: -
  - (a) Consolidate into one Order the provisions of: -
    - (i) The County of Cumbria (U5519 High Fieldside, Grasmere) (Prohibition of Waiting) Order 1983;
    - (ii) The County of Cumbria (Various Roads, Grasmere) (Prohibition of Driving of Coaches) Order 1995; and
    - (iii) Those entries in The County of Cumbria (Various Roads, South Lakeland Area) (Consolidation of Traffic Regulations) Order 2002 which relate to Grasmere.
  - (b) Clarify the exemption to the time limit in the "Parking Places, Waiting Limited to 1 Hour, Return Prohibited within 1 Hour, 9.00 am 6.00 pm, Full Week" on the U5029, being Main Street, Northern Square and Southern Square, Hawkshead (Schedule 18);
  - (c) Insofar as Grasmere is concerned:-
    - (i) Replace the seasonal restriction, ie. "No Waiting, 9 am 6 pm, Good Friday to 30 September, with "No Waiting, 9 am 6 pm, Full Week" restrictions, which would be in operation all year around.
    - (ii) Replace the current "Waiting Limited 9 am 6 pm, 30 Minutes, No Return within 30 Minutes" to "Waiting Limited 9 am 6 pm, 1 Hour, No Return within 1 hour", all year around;
    - (iii) Make the two current advisory disabled bays on College Street subject to a "Disabled Persons Parking Places At Any Time, Waiting Limited to 3 Hours, Return Prohibited within 3 Hours" restriction;
    - (iv) Alter the restriction on the parking place outside the two cottages in the middle of Pye Lane to "Residents Only Parking". Permits would be issued to each of the two cottages abutting the parking place;
    - (v) Impose "No Waiting At Any Time" restrictons on the unnamed road between Langdale Road and Red Lion Square and on Broadgate between the two parking bays, thereby creating a passing place;
    - (vi) On Highfieldside, to move the "Prohibition of Driving (Except for Access" restriction to its junction with Easedale Road; and
    - (vii) Implement a Restricted Zone on Wishing Gate Road (to include the road between its junction with the A591 and the property known as "Howe Foot"). This zone will be subject to single yellow lines "No Waiting 9 am 6 pm".
